

WEST END SCHOOL (#2265)

Enrolment Scheme Description

Effective from 10 October 2016

The guidelines for development and operation of enrolment schemes are issued under section 11G (3) of the Education Act 1989 for the purpose of describing the basis on which the Secretary's powers in relation to enrolment schemes will be exercised.

Home Zone

All students who live within the home zone described below and shown on the attached map shall be entitled to enrol at the school.

All students who live within the home zone described below* (and shown on the attached map) shall be entitled to enrol at the school.

In a clockwise direction

- The northern boundary is from the intersection of Bayly Road and Breakwater Road (north side 28 Breakwater Road) and in an eastern direction along Whiteley Street, turning left into the northern extension of Calvert Road, along Roy Terrace/Birdwood Avenue, through to French Street to that portion of St Aubyn Street that connects with the northern section of Belt Road. Continuing along Hine Street, turning left into Morley Street, along Bulkeley Terrace and ending in a line to the intersection with Dawson Street.
- The eastern boundary runs in a southerly direction the length of Dawson Street to its meeting point with Standish Street
- The southern boundary commences up Standish Street from 1/1A Wallace Place, (Tukapa Street addresses are NOT in zone) along the Wallace Place extension onto Dorset Avenue, in a westerly direction to the David Street entrance to the Taranaki Base Hospital.
- The western boundary incorporates David Street (east side 26A and west side 29) and those David Street addresses north, connecting with that portion of Lorna Street that leads onto Doone Street, (Blackmore Street, Ridd Street and Carver Place are all within zone) to the intersection with Devon Street West. Head left along Devon Street West to the intersection with Lawry Street along

Lawry Street to meet St Aubyn Street turning left along Breakwater Road to finish at the junction of the Bayly Road starting point.

Proof of residence within the home zone will be required.

Special Programmes

This priority category is not applicable at this school because the school does not run a Special programme approved by the Secretary.

Out of Zone Enrolments

Each year the board will determine the number of places which are likely to be available in the following year for the enrolment of students who live outside the home zone. The board will publish this information by notice in a daily or community newspaper circulating in the area served by the school. The notice will indicate how applications are to be made and will specify a date by which all applications must be received.

Applications for enrolment will be processed in the following order of priority:

- First Priority will be given to students who have been accepted for enrolment in the following special programme(s) run by the school and approved by the Secretary for Education. **
- Second Priority will be given to applicants who are siblings of current students.
- Third Priority will be given to applicants who are siblings of former students.
- Fourth Priority will be given to any applicant who is a child of a former student of the school.
- Fifth Priority will be given to any applicant who is either a child of an employee of the board of the school or a child of a member of the board of the school.
- Sixth Priority will be given to all other applicants.

If there are more applicants in the second, third, fourth, or fifth priority groups than there are places available, selection within the priority group will be by a ballot conducted in accordance with instructions issued by the Secretary under Section 11G(1) of the Education Act 1989. Parents will be informed of the date of any ballot by notice in a daily or community newspaper circulating in the area served by the school.

Applicants seeking second or third priority status may be required to give proof of a sibling relationship.
